

Johannes Pollak is *Pro-Rector (till July 2025) and Rector (from August 2025 onwards) and Professor of Political Science* at Sigmund Freud Private University (SFU). Beforehand, he was rector and professor at the International Relations Department at Webster Vienna Private University and Chairman of the Executive Board, Institute for European Politics (IEP) in Berlin. Prior Webster he was Head of the Department of Political Science at the Institute for Advanced Studies, Vienna where he is still a permanent non-resident fellow. Beforehand, he was Senior Researcher at the Institute for European Integration Research of the Austrian Academy of Sciences, Jean Monnet Fellow at the Schuman Centre for Advanced Studies, EUI Florence, Leverhulme Fellow at the University of Reading (UK) and Senior Visiting Fellow at the London School of Economics and Political Science. Having studied political science and philosophy at the University of Vienna, he received post-graduate education at the Institute for Advanced Studies and the LSE. His current research mainly revolves around two topics: political representation in liberal democracies with a focus on parliamentarism in the European Union and European energy policy and geopolitics. In 2021 he received the Science Prize of the Margaretha Lupac Foundation, Vienna, Austria.
