The Master's programme in Public International Law, which is conducted in cooperation with the United Nations Institute for Training and Research (UNITAR), strives to combine SFU's academic strength with UNITAR's practical focus. Since some of the courses are implemented by UNITAR, instructors include highly experienced practitioners in the diplomatic field, for example ambassadors or high-level UN staff. Through this programme, graduates acquire the ability to perform demanding legal tasks in the global environment, which equip them perfectly for working for national and supranational authorities, non-governmental organizations, international courts as well as other dispute resolution mechanisms. The programme strives to connect future leaders in international contexts by bringing together students from all over the world, who exchange views on global challenges and possible solution strategies under academic guidance. Completion of the programme in English also advances language skills, making graduates stand out in the labour market.

Apart from the legal qualifications, the Master's programme in Public International Law offers a direct connection the United Nations and its agencies:

- experience the UN work environment in Vienna first-hand
- build personal relations with UN experts and staff members
